PRODUCT DESCRIPTION:	Encore's PoolPoxi Waterborne Acrylic Swimming Pool Tie Coat is designed for use over old swimming pool paints, including chlorinated rubber and polyamide epoxy. This bonding primer provides a way to make the transition from traditional solvent based pool paints to Encore's PoolPoxi Waterborne Acrylic Swimming Pool Paint. It is also an excellent choice for priming bare concrete, plaster, Gunite and Marcite pools. It resists the chemical actions of chlorine and shock treatments, dries and cures quickly, and is VOC compliant. Cleans up and thins with water. FOR INTERIOR & EXTERIOR POOLS!

SURFACE PREPARATION:	 GENERAL: General - Improper surface preparation is the direct cause of approximately 90% of all product failures in the application of pool paint coatings! Taking shortcuts will only cause problems. The entire surface area should be clean, dry, sound and free from all dirt, grease, oils, waxes, mildew, algae, fungus, loose mortar, loose scale, chalked, cracked and peeling paint, and any other surface contaminants that may cause paint failure. Surface Repair: Repair all holes, cracks and surface breaks with a grout or non-shrinking patching material specially made for concrete, marcite or gunite swimming pool repair. Allow all repairs to thoroughly dry before proceeding. New/Unpainted Swimming Pools: All new pools must be allowed a minimum of 60 days to properly age and cure. The pool should be properly etched with a solution of one (1) gallon of muriatic acid mixed with one (1) gallon of water, or any ready-mix cleaning and etching solution. Mix and apply in accordance with label directions. Rinse thoroughly with clean water and allow 24 hours to dry thoroughly. After rinsing the surface thoroughly, wash the surface once more with a strong solution of Tri-Sodium Phosphate - (TSP), and warm water to effectively remove traces of acid and dirt, then rinse thoroughly with clean water and allow 24 - 48 hours to dry. This process should create a surface texture similar to that of 180 grit sandpaper, or this process must be repeated. Previously Painted Swimming Pools: Remove any loose scale, chalked, cracked or peeling coating from previously painted swimming pools by hand scraping, sanding, or power tool cleaning. Scrub the pool surface with a strong alkali detergent, such as TSP, using a stiff bristle brush to remove dirt, oils, suntan lotions or scum. Rinse thoroughly and allow to dry. Sand the surface with 80 grit sandpaper to remove any gloss and to create an adequate profile for adhesion. If the existing coating is severely deteriorated, completely remove exist
PRODUCT APPLICATION:	Encore's PoolPoxi Waterborne Acrylic Swimming Pool Tie Coat Stir thoroughly in a spiral up and down motion before and during application to keep product completely mixed. Working in sections, avoid application in direct sunlight by applying material in shaded areas only, and following shaded areas around the pool. Brush Applications: When applying by brush, use a quality nylon or polyester bristle brush, or a quality combination of both, and apply a smooth and generous coat on smaller surface areas, such as cutting-in larger surfaces and painting trim. Roller Application: When applying by roller cover, use a ¾" nap roller, and apply an even and generous coat in a "W" motion. Re-wet roller and cross-roll application area. Spray Application: When applying by airless spray equipment, use a unit with a minimum of 2000 psi of pressure, with 0.015 – 0.017 fluid spray tip. During spray application, it is recommended to back-roll the surface area to ensure an even coat application, and to ensure proper adhesion. Maintain a wet edge during application by brushing, rolling or spraying into previously applied coating area. During spray application, it is recommended to back-roll the surface area to ensure an even coat application, and to ensure proper adhesion. Apply when surface and ambient temperatures are above 55° F and below 90° F. Do not apply when surface and air temperature is within 5° of the dew point. Avoid exterior paint application when weather conditions are threatening, and late in the day when there is a threat of moisture condensing on wet paint. KEEP FROM FREEZING!



THINNING:	Stir thoroughly and apply as it comes from the container. Thinning is not necessary. However, if thinning is required, you may add clean water up to ½ pint per gallon.
CLEAN UP:	Clean up any minor spills and spatters immediately with warm soapy water, as well as all painting tools and airless equipment. More serious spills should be contained and removed with inert absorbent material. Dispose of contaminated absorbent, container, and unused contents in accordance with local, state and federal regulations.
Estimated Coverage:	Covers approximately 300 - 400 square feet per gallon. (Coverage will vary depending on application method, surface porosity and condition of the surface.)
ESTIMATED DRYING TIME:	To Touch: 1 - 2 hrs. To Recoat: 4 - 6 hrs. or after overnight. (@70°F & 50% RH) (Dry times listed may vary according to relative humidity, temperature, film build, and air movement.)
Precautions:	CAUTIONS: KEEP OUT OF REACH OF CHILDREN! Avoid prolonged contact with skin, and breathing of dust, vapors and/or spray mists. Causes eye irritation. USE WITH ADEQUATE VENTILATION! Ensure fresh air entry during application and drying. If you experience eye water, headache or dizziness, or if air monitoring demonstrates vapor/mist levels are above applicable limits, wear an appropriately fitted respirator, (NIOSH approved), during and after application. If you experience difficulty breathing, leave the area to obtain fresh air. If continued difficulty is experienced, get medical attention immediately. If swallowed, do not induce vomiting, get medical attention immediately.
